## **1. THE TOTAL ADVERTISING MATERIAL**

## **2. THE TASK**

The full and detailed description of the delivery is contained in DALO's Requirements Specification and the notice on [Udbud.dk](http://Udbud.dk).

## **3. TECHNICAL SPECIFICATIONS AND STANDARDS**

The tender material may refer to technical specifications in the form of specific products (e.g., by Nato Stock No. or part number) or standards (e.g., ISO). This is to be understood only as a reference to the required quality. All such references are therefore to be understood to include the words "or equivalent". Equivalent products or services that fulfil the same purpose and have a similar quality may therefore also be offered.

#### **4. DELIVERY AND TERMS OF DELIVERY**

Time of delivery shall be in accordance with the time of delivery stipulated in the Requirements Specification.

Delivery shall be quoted in accordance with the delivery term Delivered Skrydstrup, Denmark, Duty Paid (DDP - Incoterms 2020).

#### **5. AWARD CRITERIA**

The agreement will be awarded to the tender with the lowest price.

Should the situation arise, that two tenders offers the same price and these are the lowest offered, DALO will choose the tender with the shortest time of delivery. Should two tender offer both the same and lowest price, and the same time of delivery, DALO will decide which offer will be successful by drawing lots with due observance of the principle of equality of opportunity.

The total price and the delivery time from the successful tenderer will be published after award.



## 6. RESERVATIONS

**Reservations** to the tender material are not accepted. If the offer contains such reservations, the offer will be deemed non-compliant and will no longer be considered.

## 8. CONTENT OF THE OFFER

The offer must be in English or Danish.

The offer must include the following:

- Tender submission letter - preferably using the DALO template.
- Signal Diagram of the Headset (cf. Requirement Specification point No. 4)

It is important that the tenderer does **not** attach its own standard terms and conditions or other material not requested by DALO.

## **9. DEADLINE FOR SUBMISSION OF OFFERS AND PERIOD OF VALIDITY OF OFFERS**

Offers must be submitted by e-mail to [FMI-KTP-SC-TENDER@mil.dk](mailto:FMI-KTP-SC-TENDER@mil.dk)

not later than **21<sup>th</sup> October 2024 at 13:00** Offers received after this date and time will not be considered.

The tenderer must keep open its offer for three (3) months after the time-limit for submission of offers.

## **10. PROCESSING OF TENDERS, COMPLAINTS PROCEDURE ETC.**

DALO does not consider the tender procedure closed until an agreement has been concluded, and DALO reserves the right to cancel the tender procedure. Irrespective of whether the agreement has been awarded to another tenderer, the tenderer is bound by the offer until the expiry of the period of validity of the offer.

If the agreement is awarded to a group of operators (a consortium), each participant of the consortium must undertake joint and several liability and appoint a joint representative authorised to be DALO's point of contact for the group.

Complaints of the award must be lodged with the Danish Complaints Board for Public Procurement with a copy to DALO not later than 45 (forty-five) calendar days after receipt of the letter of rejection. However, the Danish Complaints Board for Public Procurement can only process matters where the contract put up for tender has a clear cross-border interest, or matters relating to contracts above the thresholds set out in the Danish Public Procurement Act or the Defence and Security Directive.

## **11. CURRENCY**

If an offer is submitted in another currency than DKK, DALO will, for the purpose of the evaluation, convert the price to DKK on the basis of the rate of exchange on the date of the expiry of the time-limit for submission of offers, see clause 9.
