With the European Union's Corporate Sustainability Reporting Directive (CSRD) now in effect in Sweden as of 1 July, 2024, the largest companies across Europe have begun preparing for their comprehensive sustainability reports. Starting from 2025, companies with over 250 employees will also need to report. This legislation is reshaping how businesses approach sustainability, requiring extensive data collection and reporting across entire supply chains.

Additionally, the Corporate Sustainability Due Diligence Directive (CSDDD), effective in 2027, will mandate that companies implement robust control systems to verify sustainability standards within international subsidiaries and value chains. While many large companies have already established basic frameworks, significant improvements will be required to align with these enhanced standards.

For businesses operating within global supply chains, particularly in regions where ESG (Environmental, Social, and Governance) practices may lag behind European standards, understanding the current situation is key.
