With the European Union's Corporate Sustainability Reporting Directive (CSRD) now in effect in Sweden as of 1 July 2024, the largest companies across Europe have begun preparing for their detailed sustainability reports. Starting from 2025, companies with over 250 employees will also need to report, making value chain transparency a critical requirement.

Additionally, the Corporate Sustainability Due Diligence Directive (CSDDD), effective in 2027, will mandate that companies establish robust systems to verify sustainability standards in foreign subsidiaries and supply chains. While many large companies already have foundational systems in place, improvements across the value chain are increasingly necessary.

For companies with suppliers in developing regions, particularly in Asia and China, aligning with European ESG standards presents unique challenges. Supply chain ESG data collection is often inconsistent, and bridging the gap between expectations and reality requires sustained effort.
